#### **Personal Independence Payment**

Personal Independence Payment (PIP) is a benefit to help with the extra costs of living with a long term disability or health problem.

It is replacing Disability Living Allowance for people age 16 to 64.

If you have a child under

Once they reach their 16th birthday they will be asked to claim PIP.

PIP is not a taxable benefit and is paid on top of any other benefit or tax credits. It can still be claimed if the disabled person is working or studying.

If you or your child has a disability, contact the Welfare Rights Team for more information. We can explain the criteria for PIP and may be able to help with claim forms.

If someone in your family received DLA or PIP they may be entitled to additional benefits within tax credit or housing benefit.

#### **Employment and Support Allowance**

Employment and Support Allowance is replacing Incapacity Benefit and Income Support for people who are unable to work because of health problems.

Welfare Rights an support you with detailed information for any one who is unhappy with a decision on their ESA Claim.

Please contact us for further advice if you disagree with a decision that you do not qualify for ESA.

For most people, ESA is a means-tested after 12 months. If you

have other resources for example private pensions or if your partner works, your ESA may reduce or stop.

### **Benefit Cap Reduction**

The Benefit Cap is a limit on the total amount of money people can get from certain welfare benefits, including housing benefit—£26,000 a year for couples and people with children and £18,200 for single people.

After November 2016 these amounts will reduce further to £20,000 (around £385 a week) for couple and people with children, and £13,400 (around 258 a week) for single people.

Those affected by the new limited will

be receiving letters from the DWP (Department for Work and Pensions) over the next few weeks.

# Are you a carer?

A carer is someone who looks after a friend, relative or neighbour who is elderly, ill or disabled and could not manage without the carers help.

Caring can be time consuming and stressful, so carers need to make sure that they looks after themselves as well as their loved one.

Some carers can be paid carers allowance of £62.10 per week and older carer's may get extra payments in their pension credit or housing benefit.



#### **Case study**

A citizen of Sandwell and her partner live with parents. Welfare Rights visited them and they were receiving Job Seekers Allowance, Child Tax Credit and Child Benefit for their 6 month old son.

A Personal Independence Payment form was completed for the client because she had a learning disability and suffers with anxiety outdoors.

The claim was successful and Enhanced Rate Care and lower rate mobility was awarded, Carers Allowance has been claimed and additional income support. The family received extra benefit gained of £204.80 per week.
